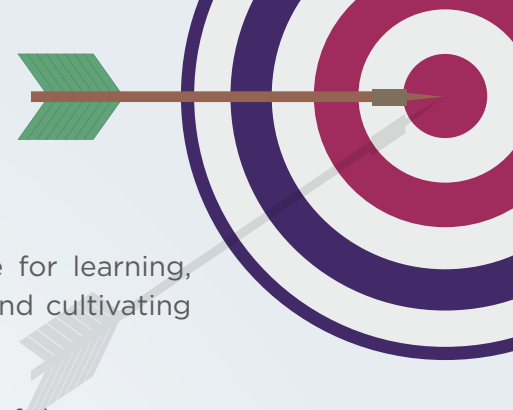


VISION

FACILITIES

The college has its own building with spacious and well-equipped classrooms. There is an auditorium to conduct seminars and guest lectures. There is also a moot court hall, library, computer laboratory and students' common room.

• LIBRARY

The college has a well-equipped library with state-of-the-art facilities and over 10,000 law books including textbooks and reference books. Additionally, the college subscribes to periodicals, law journals and national and international law reports. Students are provided with the facility to borrow or photocopy the study material. The college library also has an "Institutional Membership" with National Law School of India University, Bengaluru.

• COMPUTER LAB

The college has a computer lab with more than 25 laptops with internet facilities to enable students to enrich their knowledge with modern technology and access to online legal databases such as Manupatra and Westlaw for legal research.

• ACCESS TO PARENT & STUDENT ON-LINE INFORMATION SYSTEM

The college has an on-line student information system "Jagriti" to enable the parents to know their wards' academic performance. Results of tests, assignment scores and attendance details of students are regularly uploaded on the portal which can be easily accessed.

- **MOOT COURT HALL**

The college has a spacious, well-furnished Moot Court hall to conduct intra and inter college Moot Court competitions.

- **SPORTS COMPLEX**

There is a sports complex in the campus for all indoor and outdoor games.

- **HOSTEL**

The college offers separate hostels for boys and girls within the campus with well-furnished individual/shared rooms. The hostels provide mess facility with healthy and wholesome food.

- **CAFETERIA**

Within the campus, there is a cafeteria with a variety of food and beverages available for purchase.

- **MEDICAL AND HEALTH CARE**

There is a hospital with all super specialties to take care of health issues. Students are provided with health insurance. The campus has a Yoga Centre, Gokula Ayush Arogyadhama and a Fitness Centre.

- **BANK AND POST OFFICE**

The students have convenient access to banking facilities and postal services located within the campus.

For the safety of the students, the college is under constant CCTV surveillance.

ACTIVITIES

Lawyers are not made from books alone, but through their experience in the outside world. With the aim of providing a holistic environment for legal study, the college provides opportunities for the various activities comprising of both co-curricular and extra-curricular activities.

- Art of advocacy can only be acquired through constant practice and this is enabled through the Moot Court Society of the college. The society has members selected on the basis of performance in the annual intra-college moot court competition. The society ensures that students get adequate opportunity for mooting, trial advocacy, judgment writing, legal research etc. by prompting them to take part in national and international competitions. The society also organizes the National Level Moot Court Competitions in the college.
- Like the Moot Court Society, the college has a Debate Society, popularly known as “DebSoc” to introduce students to various forms of debating. It is a forum for all those students who are passionate about putting forth their opinions, ideas and beliefs. The DebSoc facilitates students to participate in parliamentary debates, Model United Nations and various national and international debates.
- The Legal Aid Committee and the NSS Committee of the college carries out activities along with the students to provide legal assistance and promote legal awareness amongst the community, especially for the poor and the needy. The committee encourage students to come forward with innovative ideas to help non-lawyers learn about law.
- The college has an active Placement Cell which renders complete assistance to students in career guidance and liaisons with business and industry. The cell provides internship and helps in placing students in reputed law firms, companies and other organizations.

- The college publishes a law journal, the MS Ramaiah Journal of Law, which has original contributions from highly reputed legal luminaries and other renowned persons.
- The college also provides a platform for the students to voice their opinions by publishing its Magazine – Legalia and Newsletter- Sadhana. For better exposure and understanding of the students, Seminars and Guest Lectures are organized from time to time.
- The college offers a Personality Development and Orientation Programme every year for first year upon joining the college. The students are given an assessment test to analyze their Strengths, Weaknesses, Opportunities and Challenges (SWOC) so as to provide adequate assistance throughout the course.
- To nurture and cherish the various talents of the students, college has a Sports Committee and a Cultural Committee, which facilitate student participation in various sports and cultural activities respectively. The college conducts the annual cultural fest, sports day and celebrates all national days and various festivals such as Karnataka Rajyotsava, Onam, Farewell, Fresher's Day etc.
- Mentoring is a unique method of supporting students to improve their learning and leadership skills and motivating them towards their future career development. With this in mind, the college has a mentorship programme wherein the faculty is given training on mentor system and they meet the students on a regular basis to listen to the issues of the students and guide them on their overall personality development.
- Go Green Club takes various initiatives to create awareness about environmental issues and to promote environment friendly practices within and beyond the campus.
- Some of the other committees that work for Student Welfare are Women Grievance Redressal Cell & Student Grievance Redressal Cell.
- The Anti-Ragging Committee of the college ensures that ragging or any other misconduct does not occur inside or outside the college premises and strict action is taken against the students involved in such activities.
