NEW INITIATIVES OF RCL

CENTRE FOR HUMAN RIGHTS, IHL AND REFUGEE LAWS

The Centre for Human Rights, IHL and Refugee Laws was established in September 2020, with the aim of creating social awareness about issues related to Human Rights, IHL and Refugee Laws. The focus shall be on undertaking research in core areas of Human Rights, IHL and Refugee Laws, with the active participation of students.

The objectives of the Centre are:

- To create social awareness about the problems and to educate regarding the policies relating to Human Rights, IHL and Refugees.
- The Centre intends to enter into collaborations with other stakeholders and also to undertake research activities on the contemporary issues on Human Rights, Refugees and IHL.
- To initiate projects to promote the dissemination of information related to basic human rights, solutions available in case of violations and also conduct studies in the areas that affect refugees within India and globally.

CENTRE FOR WOMEN AND CHILD WELFARE POLICY

The Centre for Women and Child Welfare Policy was established in November 2020. The Centre works towards the development of Women and Children. The Centre functions under the guidance of Prof. (Dr.) Rose Varghese, Director (Academics), RCL and Prof. (Dr.) V. Shyam Kishore, Principal In-charge, RCL.

PROJECTS AND COLLABORATIONS

RISHII: RESOURCES FOR INTERNATIONALISATION OF HIGHER EDUCATION INSTITUTIONS IN INDIA PROJECT

RCL is a partner institution for the project on Resources for Internationalisation of Higher Education Institutions in India (RISHII) in collaboration with 19 partner Institutions across India and Europe, with the project being coordinated by the University of Deusto, Spain. The project aims to contribute to the modernization of Indian Higher Education through equipping the Indian Higher Education Institutions with procedures, tools, human resources and continuous professional development mechanisms necessary for Curriculum Internationalization and creating institution-wide thriving cultures of Internationalization. The project is coordinated by Dr. Chetan Singai, Associate Professor, Ramaiah University of Applied Sciences and Ms. Rajashree. K, Assistant Professor Sr. Scale(Law).RCL.

PROJECT ON POLICE SYSTEM IN INDIA

In India, the year 2019 -20 marks the 70th anniversary year of adoption of the Indian Constitution. On this occasion, it is important to review and analyse the working of Criminal Justice System in the country. The Government of India initiated some steps to revamp the criminal justice system. Police, the most visible face of

the government, sets the wheels of Criminal Justice System in motion. It is, therefore, becomes important to study the Police system in India keeping the federal structure in mind. A group of academicians, practitioners, experts and researchers, along with Menon Institute of Legal Advocacy Training (MILAT) - a think tank - have started a project 'Police System in India'. This project will be published in book form with state-wise volume for all the States and Union Territories as well as the central police organizations (separately about 35 volumes by 2021). It is expected that the data and findings in this project report will contribute to a better understanding of the priority areas in policing while focusing on greater public welfare. Ramaiah College of Law, Bengaluru has been working on the project & representing for the Karnataka State Police from June 2020.

MOU WITH BIMACC

Ramaiah College of Law, Centre for Legal Aid and ADR Studies (CLAAS) has agreed to enter into a Memorandum of Understanding with Bangalore International Mediation Arbitration and Conciliation Centre (BIMACC). The objective of the MOU is to strengthen the legal aid and ADR activities at RCL by conducting mediation training programmes, organizing guest lectures, conducting National ADR Competitions besides organizing legal aid camps and awareness programmes.

The revised vision and mission of RCL and the proposed activities were also placed before the Council for their consideration.

3RD SURANA & SURANA & DR. M.S. RAMAIAH NATIONAL TORT LAW MOOT COURT COMPETITION & JUDGMENT WRITING COMPETITION, 2020

The 3rd Surana & Surana and Dr. M.S. Ramaiah National Tort Law Moot Court Competition & Judgment Writing Competition, 2020 was virtually organised by RCL, Bengaluru in collaboration with the Surana & Surana International Attorneys from August 28 to 30, 2020. Despite the challenging circumstances created by the public health emergency that we witnessed across the globe, the competition received an overwhelming response with the participation of a total of 48 teams from all over India.


On the first day of the Competition, a researcher's test was conducted and on the basis of researcher's test scores and memorial scores, the top 16 teams were promoted to the Octa-Final Rounds. The Octa Finals and the Quarter Final Rounds were conducted on the second day. The four highest scoring teams from these rounds got promoted to the Semi-Finals. The Semi-Finals and the Finals were conducted on the third and the final day followed by a Valedictory Session on the same day.

In the Final Round that witnessed awe-inspiring, formidable and lively performances from the participating teams, the University Law College, Bangalore emerged as the Winners of the Competition while the Tamil Nadu National Law University secured the 2nd position. The Maharashtra National Law University, Nagpur obtained the 3rd position in the Competition.

In the Judgment Writing competition which was held as a part of the Competition, the participants were required to write and submit the judgements on the same moot problem. Pravin Gandhi College of Law, Mumbai emerged as the Winners.

AWARENESS PROGRAMME FOR STUDENTS OF PROFESSIONAL COURSES UNDER GEF

The Centre for Legal Aid and Alternative Dispute Resolution Studies (CLAAS) conducted an awareness programme virtually on January 18, 2021 on the topic titled "Mediation - The Best Option for Conflict Resolution. The Programme enhances unique institutional activities, making our institution distinct in that our focus is not on exclusive theoretical knowledge.



This Project studies the current status of various Geographical Indications of Karnataka, individually, and submits the report to VTPC to facilitate the undertaking of various developmental activities for the promotion of GI. In the first phase, the research teams, consisting of faculty members and students from various disciplines including RCL, Ramaiah Institute of Management, and Ramaiah Institute of Applied Sciences have conducted studies on two identified GIs in Karnataka namely Mysore Rosewood Inlay and Bidriware. The Report on Bidriware was submitted & a Trademark application was also granted to a renowned partnership firm in December, 2020. The Consultation for two important Geographical Indication applications i.e. Patteda Anchu & Melkote Pancheis completed. The Project report for Mysore Pak is completed and under review.



KEDARNATH SINGH Vs. STATE OF BIHAR

Sedition is a conduct or speech inciting people to rebel against state. The law of sedition was introduced as Section 113 of Indian Penal Code, by Thomas Macaulay in his draft of 1837. This was omitted from the original IPC. The offence of sedition was included in the IPC as a response to the Wahabi movement. This movement which was led by Syed Ahmed Barelvi, focused to condemn and protest against the changes that were brought into the original Islam. When the movement turned into armed resistance against British, the colonial rulers felt the need to implement the sedition law.

Facts of the Case:

KedarNath Singh, a member of Forward Communist Party was charged under section 124A and 505 for a speech delivered by him in Barauni, a town in Bihar. In his speech, he used the term "dogs" for the C.I.D officers and "goondas" for Indian National Congress party. Further, he stated that people should "strike and turn out these congress goondas in the similar manner, as that of the Britishers, and that he believes in revolutions which burn the capitalists, zamindars and the congress leaders of India into ashes, and will establish government for the poor and downtrodden people of India on those ashes."

The Patna High Court upheld the charges and sentenced him with one year imprisonment, by considering the speech to be full of incitements to revolution and was not criticizing any particular policy or measures of the government. This judgement was appealed to the Supreme Court of India. Along with this case the court took up three more cases.

Issues:

The Supreme Court of India considered two issues:

- 1. Whether the sections 124A and 505 of IPC have is consistent with Article 19(1) (a) of the Constitution.
- 2. Whether the restrictions that is imposed on the fundamental right to freedom of speech is in the interest of public order and within the ambit of legislative interference.

Decision:

The Court stated that the fundamental right that is guaranteed by Article 19(1)(a) of freedom of speech and expression is not an absolute right and that it is subject to the reasonable restrictions under Article 19(2).

Further the Court referred to the judgements made by the Federal Court of India in Niharendu Dutt Majumdar vs. The King Emperor [1943] F.C.R. 38 and the Privy Council in King -Emperor vs Sadashiv Narayan Bhalerao I.L.R. (1947) IndAp 89. The Federal Court of India held that the violent words expressed either by speech or writing would not amount to sedition, but if it either incited disorder or satisfied ordinary prudent man that there was intention or tendency, then it would amount to sedition. Whereas the Privy Council held that the offence consisted of exciting or attempting to incite bad feelings towards the government.

The Court stated that the section is constitutional if it was interpreted according to the judgement of Federal Court of India as it falls within the ambit of the reasonable restrictions, but it is unconstitutional if it is interpreted according to the judgement of Privy Council. The Court also stated that it had taken care to indicate clearly that the strong words used to express disapprobation of the measures of the government with a view to their improvement or alteration by lawful means would not come within the section.

In the R.M.D Chamarbaugwalla v Union of India, [1957]1SCR930, the Honorable Supreme Court of India stated that if certain provisions of law construed in one way would make them consistent with the Constitution, and another interpretation would make it inconsistent, then the Court would lean towards the former. By applying this ratio decidendi, the court limited the operation of sedition to only those activities that involved incitement to violence or intention or tendency to create public disorder or cause disturbance of public peace. A citizen who criticizes the Government for policy without inciting violence is not seditious. Hence, the Honorable Court upheld the constitutionality of section 124A in the interest of public order and within the ambit of permissible legislative interference with that fundamental right.

Indian Constitution vis-a-vis the Right to Religion, Secularism, and Pluralism

Any debate in India on religious freedom is incomplete without reference to secularism, and a plethora of scholarly work exists on the topic. However, the idea of secularism has often been misunderstood and mis-applied by legal professionals, politicians and even courts. This article delves into how institutions in India have used 'secularism' to mean something it is not and how the Constitution views religion.

The Supreme Court in SR Bommai v. Union of India understood 'secularism' as an idea of accommodation of all religions. Further, in Indra Sawhney v. Union of India, the Supreme Court held secularism as a concept of cohesion, tolerance and unity between all religions. The politicians, now and even then, have used the term secularism the same way the Courts have.

However, is the meaning attributed to secularism by judiciary and politicians in fact the meaning of secularism? How does the concept of pluralism play out within the ambit of right to religion?

Dissecting the meaning of secularism and pluralism

Secularism is defined by the Merriam Webster dictionary as- "indifference to or rejection or exclusion of religion and religious considerations". The Cambridge Dictionary defines secularism as- "the belief that religion should not be involved with the ordinary social and political activities of a country". And Vocabulary.com defines secularism as "a doctrine that rejects religion and religious considerations".

The common idea traversing through all these definitions is that secularism is a political ideology in which the State distances itself from all religions. It never accepts religion as a factor in governance, if not reject it completely.

At this juncture, it becomes pertinent to know the meaning of a similar word- pluralism.

Pluralism is defined as "The existence of many different groups of people in one society, for example people of different races or of different political or religious beliefs".

A cursory reading of the meaning of pluralism points out that the Supreme Court and politicians have been using 'secularism' to mean 'pluralism'.

This leads to the question- How does it matter as long as there is consensus and harmonious application of the doctrine of secularism and pluralism?

Unfortunately, even pluralism does not resolve the issue because our Constitution is not plural. The issue India is facing legally and politically is not merely of penurious vocabulary but of great political and legal implications to the extent of affecting fundamental rights of the citizens.

Secularism is inviolably linked to right to religion. And to understand the implications of the failure to appreciate the true constitutional scheme vis a vis right to religion, one must merely read the provisions under Part III of the Constitution.

The Constitutional Scheme

Fundamental Rights recognized under Part III of our Constitution have been interpreted and expanded by the judiciary in innumerable cases. The constituent assembly has also spoken extensively on the point of protection of religious freedoms of people and concept of secularism.

Article 13(2), 13(3), and Article 25 of the Constitution will provide more or less a comprehensive idea of the relation between the fundamental rights and religion. What people often miss is that Article 25, among other things, is also subject to 'other provisions of part III'. In other words, whenever there is a conflict between any fundamental right and Article 25, Article 25 will fail. Article 25 has been afforded the least value among all the fundamental rights.

Further, Article 13(2) declares all laws contrary to part III as void. And 13(3) defines law to include even customs. Therefore, the scope of Article 13(2) is not limited to legislative or executive actions but also customs of the society; including religious customs.

Therefore, every time an argument is made claiming a religious practice to be discriminatory or undignified or arbitrary, such religious practice will be struck down even if it is a religious practice protected under Article 25, absent the limitations therein. Whether it is the Sabarimala case or the triple talaq case, equality and dignity will always prevail over religion. This notion challenges the 'doctrine of essential religious practices' applied by the supreme court to determine which religious practices are protected, as every practice which is contrary to fundamental rights should be struck down irrespective of whether is essential or not.

Article 25 and Pluralism

Article 25 stands out in part III due to its limitation- subject to other provisions of part III. This presents a contradiction between pluralistic conception of the State envisaged in the Preamble and right to religion under Article 25.

When the Constitution endows right to religion under Article 25 a lower status compared to other fundamental rights, it is more like the Constitution saying to the people- "You will have the fundamental right to practice, profess and propagate your religion, but if you violate other fundamental rights, I will declare it void". This scheme is contrary to the idea of pluralism. Pluralism means inclusion of all religions and their believes. But as per Part III, not all religious practices are allowed in India.

And inevitably the restriction placed by Article 25 applies differently to different religions. The more a religion has unconstitutional practices, the less it will be allowed to be practiced.

Religiosity and Right to Religion

Being religious in the true meaning of the word, means following what the religious scriptures say. However, there is a limit to the scope of interpretation and sometimes not even outrageous and audacious interpretations can put humanity into otherwise inhumane practices of religions- such as caste system in Hinduism, or Islam's view on adultery and punishment for homosexuality in Christianity.

If one has to remain truly religious, one has to adhere to every religious law in letter and spirit. But in India it is not possible to be religious in the strict meaning of the word, because the Constitution will declare religious practices void and unconstitutional if they are discriminatory and inhumane. Constitutionally speaking, Constitution accepts only those religious practices which are constitutionally sound and permissible; and not those which are 'essential to the religion'.

Therefore, Constitution of India is not plural in the strict meaning of the term. Plurality will mean acceptance of a practice which, though inhumane and immoral, if the members practicing it recognize it to be legitimate.

Furthermore, the Constitution is not secular as it 'intervenes' and actively engages in the religious affairs of the people, and consequently the State.

Secularism and Governance

An argument can be made for secularism in our political governance (the real meaning of secularism and not the Indian-ised version of it), in the sense that it is indifferent to religions or religious practices. But it will be an error to call the Constitution secular, i.e. indifferent towards religions.

It may be argued that there is no place for secularism in religious matters and places of worship. However, the Constitution does not recognize this separation between religious affairs and governance of the State. The Constitution rather takes a leap forward and states that any religious law (in the form of practice or custom) shall not violate other fundamental rights.

The Contradiction

There is a fundamental contradiction between religions and Article 14, 21, and Article 51(h) of the Constitution. Religion is based on faith, and science on evidence and facts. Religions are often discriminatory towards weaker sections of the society whereas the Constitution under Article 14 and 21 uphold the equal rights of all individuals. This does not mean that all religions are equal for the Constitution. The Constitution rejects religions (or parts of it) in proportion to their inhumane and discriminatory characters. The more a religion is discriminatory, the less it will be allowed to exist.

Therefore, the relationship of the Constitution and religion needs to be carefully understood before tagging it with concepts like secularism or pluralism.

INDRA SAWHNEY Vs. UNION OF INDIA AIR 1993 SC 477

Facts - The first backward commission was formed in 1953 which is popularly known as Kaka Kalelkar's commission. It submitted its report on 30th March 1955 listing out that 2399 castes are socially and educationally backward classes. The Central Government didn't accept the report but later in 1979 backward commission which is known as Mandal commission was setup to investigate the socially and educationally backward classes. This commission which was headed by prime minister Sri. Morarji Desai. The commission submitted its report on December 1980, listing 3743 castes that are socially and educationally backward classes and recommended for reservation of 27% in government jobs and public appointment. But due to internal disturbance within the party the government collapsed and it couldn't implement the recommendation made by Mandal commission report. Thereafter the congress government headed by the Prime Minister Smt. Indira Gandhi came to power at center but she didn't implement the Mandal commission report till 1989. But later when the Janata Dal government came to power, they decided to implement the report of the commission. On 7th August 1990, Prime Minister V.P.Singh promised that if he becomes prime minister he will implement Mandal commission recommendation and he even kept his promise. Subsequently, he issued office of memorandum which stated that, there will be 27% reservation for OBC's. As soon as this memorandum was issued there was turmoil everywhere in the country. So, a writ petition was filled from Bar Association of the Supreme Court challenging the validity of the office memorandum issued by the government. The case was ultimately decided by the 5 judge bench. They issued a stay order till the final disposal of the case on 1st October 1990. Unfortunately, Janata Dal Government again collapsed due to defection and in 1991 by the parliamentary election, the congress was formed again. So again to incur the situation and also for the political gain the then Prime Minister P.V. Narshima Rao issued another office of memorandum by making two changes; one is to introduce the economic criterion in granting reservation within 27% in Government jobs and another 10% of vacancies for the socially and educationally backward classes which brings out to a total 37% reservation.

Issues involved:

- Whether Article 16(4) of the Constitution supersedes Article 16(1)?
- Whether there can be further classification in the already classified backward classes?
- Whether the extent of reservation can exceed 50%?

Judgement - The nine-judge constitution bench of the Supreme Court by 6:3 majority held that the decision of the Union Government to hold 27% reservation for socially and educationally backward classes is valid. But the Court struck down the second provision of office Memorandum and held that holding 10% Government occupations for the socially and educationally backward classes is not valid as Backward Classes of a citizen in Article 16(4) can be identified on the basis of the caste system and not only on an economic basis. Article 16(4) is not an exception of Article 16(1). It is an instance of classification reservation which can be made under Article 16(4) and Backward classes in Article 16(4) were not similar to as socially and educationally backward in Article 15(4). And also reservation shall not exceed 50%. Also Article 16(4) permits classification of background classes into backward and more backward classes and there is no reservation in promotion. Reservation cannot be made by Executive Officer. Majority held that there is no need to express any opinion on the correctness and the adequacy of the exercise done by the Mandal commission. Permanent statutory body is to be formed to examine complains of over inclusion and under inclusion. Disputes regarding new criteria can be raised only in the Supreme Court.

ANIMAL CRUELTY

As it has been rightly said by Ricky Gervais, 'The greatest privilege that comes with freedom of speech is using your voice for those who don't have one'. Why humans are called greedy and selfish when it comes to their needs and wants? We are the voice for them and harming those, means taking a war with the ecosystem. The rise in the number of cruelty incidents towards animals, such as throwing a dog from the rooftop, burning animals alive, using animal's skin for the textile industry and the cosmetic industry has compelled animal rights activists to raise their voice against such acts. Animals in India gets a non-human status, wherein they are treated as a commodity or property. Animal brutality is maltreatment toward or disregard of an animal.

In Animal Welfare Board of India v. A. Nagaraja & Ors., it was held that Bulls must not be used in any kind of races or bullfights and Right to Life under Article 21 shall be extended to animals too. And as far as their freedoms are concerned, they must be protected by the Government and Animal Welfare Board.

Bombay High Court in People for Ethical Treatment of Animals v. UOI said that if any film wants to use an animal for public viewing has to issue a certificate from the Animal Welfare Board stating that the provisions of the Performing Animals Rules, 2001 have been duly met. This ruling safeguards animals from abuses, being exposed to loud noises, beaten or kept without food and water.

After the enforcement of Prevention of Cruelty to Animals Act (PCA)1960, there have been a dreadful rise in the cases of animal cruelty. Wildlife Protection Act, 1972 was also established for the protection of animal species. There are many other laws made to crackdown the danger against animal cruelty for their safety, protection and punishment in cases of animal cruelty such as Article 48A and 51A(g) of the Indian Constitution, Section 428 and 429 under Indian Penal Code. Out of all, PCA Act,1960 and Wildlife Protection Act, 1972 are the most important ones. The major escape clause which needs an immediate action is the amount of fine that is imposed on any offence under PCA Act is very less.

In Uttar Pradesh, a commendable initiative has been taken towards the prevention of cow slaughter. It provides for the protection of cows and to prevent their slaughter, also, providing for rigorous imprisonment of 10 years along with a fine of INR.5 lakhs.

The initial step ought to be is to teach kids to have regard for animals and treat them kindly. We can forestall pitilessness to animals by requesting stricter laws for the assurance of animals. Animal and non-animal social sectors must recognize their intersectionality and work together. Government assistance to animals is also getting seriously undermined as there is no legitimate state-level body to screen and implement Government assistance laws and to bring animal related government assistance ideas into the arrangement of the State Government. Another recommendation to upgrade the system is to set up and fortify the general public for Prevention of Cruelty to Animals, an NGO that can work in each state freely with no impedance of the State. Similarly, there is a need to guarantee that the State Animal Welfare Board runs suitably, considering the way that in numerous states there is no such load up. These little changes by different adherence can change the circumstance for animals in India, and no mercilessness of any sort would be accessible in our overall population.

The legislature has a basic limit, i.e., on the off chance that the controls for such kinds of offence can be made stricter, at that point, everybody will endeavor to admission the well and won't viciously murder faultless animals. The government should provide food and shelter to street dogs.

In 2011, the Prevention of Cruelty to Animals was updated and renamed as Indian Animal Welfare Act as a need was felt to change the old law. Despite such an enormous number of laws, the drive will simply come when people cooperate with each living animal's good judgment, qualification bodies and affiliation and attempt to improvise the pitiable condition of animals.


