

## **ADMISSION POLICY 2021-22**

The admission to Ramaiah College of Law follows a transparent, methodical and merit-based process which has enabled us in achieving excellence in legal education.

- There are two steps for any candidate who applies for the Five-Year Integrated B.A.,LL.B. / B.Com.,LL.B. / B.B.A.,LL.B. Course, namely the filling up of the "Application Form for Registration" and the "Application Form for Admission".
- ➤ The registration to various programmes offered by Ramaiah College of Law will commence from April, 2021. Candidates can obtain the "Application Form for Registration" from the College website i.e., www.msrcl.org
- > Only candidates who have submitted "Application Form for Registration" will be eligible to participate in the admission process.
- > The admission process shall be as follows:
  - An Admission Process Review Committee (APRC) comprising of the Director (Academics), the Principal, and administrative office in-charge shall supervise and approve the admission through a selection process.
  - A candidate belonging to the General Category with minimum 45% marks and above (in case of SC/ST 40%) at the 10+2 level, will be eligible for the selection process.
  - Upon receipt of the duly filled Application Form for Registration, the candidate will have a telephonic interview with the Director (Academics), Ramaiah College of Law.
  - After the interview, you are required to intimate us by email at <a href="info@msrcl.org">info@msrcl.org</a>. If you qualify the interview you are required to fill the Application Form for Admission which will be mailed to you from the Administrative Office.
  - The candidate will also submit the 1<sup>st</sup> year college fee along with the admission form within 3 days from the date of Interview. The fee will be collected through Demand Draft / NEFT / RTGS.
  - Waitlisted candidates will not make any payments in lieu of fee to the college till they receive specific instruction from college to pay.
  - A fee concession of 05% will be given for SC/ST students for first year only.
- After securing admission, students who wish to withdraw their candidature shall be given reimbursement in the following manner:
  - Full refund of the fees for the withdrawal before 15/07/2021. However, a Processing fee of Rs.5000 will be deducted.
  - 90% of the total annual fee will be refunded for withdrawal between 16/07/2021 and 23/07/2021.
  - 80% of the total annual fee will be refunded for withdrawal between 24/07/2021 and 30/07/2021.

- 70% of the total annual fee will be refunded for withdrawal between 31/07/2021 and 06/08/2021.
- 60% of the total annual fee will be refunded for withdrawal between 07/08/2021 and 13/08/2021.
- 50% of the total annual fee will be refunded for withdrawal between 14/08/2021 and the date of commencement of class.
- There will be no refund for withdrawals after commencement of classes.
- Further, students who opt to discontinue the course after commencement of classes are under the obligation to pay the full course fee subject to the policies of the college.
- > The decision of the Management regarding admission of a candidate shall be final.
- Please note that the admission to the college is only provisional and subject to the candidate fulfilling all eligibility criteria and other conditions that may be prescribed by the admission notification of the Karnataka State Law University, Hubballi.
