ELIGIBILITY CERTIFICATE

➤ The applicant who has passed the prescribed qualifying examination from recognized University/Boards of examination that are situated outside Karnataka or in a Foreign country shall **compulsorily obtain** the ELIGIBILITY CERTIFICATE through (online) **Seva Sindhu portal** before taking the admission.

1. Candidates may apply for the Eligibility Certificates to the KSLU through online on Seva Sindhu web portal to the office of K.S.L.U., Hubballi along with original/attested documents of 10th, 12th Std marks card along with the transcripts issued by the concerned University or Board or Department.
2. The Eligibility Certificate will be issued online by the University for those candidates who have obtained their qualifying degree/certificate from recognized board / University situated outside the Karnataka state and all the foreign candidates/applicants.
3. The qualifying degree/certificates and marks cards should be in Kannada or English only.
4. All those candidates who have obtained qualifying degree/certificate from outside the Karnataka state should produce the countersigned original certificates from the issuing authorities/universities, otherwise eligibility will not be considered.
5. Fees for Eligibility certificate for 5 year Law programme Rs.3500/- (Rupees Three thousand five hundred only) for Indian students and Rs.16,000/- (Rupees Sixteen thousand only) for Foreign students.

Note:

Students have to apply for eligibility certificate through Seva Sindhu portal from 11.05.2025 to 27.05.2025.

ADMISSION GUIDELINES

1. Instructions to the affiliated Law Colleges regarding the admissions to 5 year Law Programmes for the academic year 2025-26.

The applications for admission and the admission statement should be as per Proforma prescribed by the University. The duly filled in admission statements in Proforma-1, 2 3 and 4, shall be sent to aracademic.kslu@gmail.com in MS excel format

The applications for admission and the admission statement should be as per Proforma prescribed by the University. The duly filled in admission statements in **Proforma-1, 2 3 and 4**, shall be sent to aracademic.kslu@gmail.com in MS excel format mandatorily on or before 8th July 2025. Admissions shall be made purely on **Merit cum Reservation Basis**.

The eligibility for admission is as given below:

A) 5 year LL.B course :

(a) An applicant who has successfully completed Pre-University course or Senior Secondary School course ('+2') or equivalent such as (11+1, 'A' level in Senior School Leaving Certificate Course) from a recognized University of India or outside or from Senior Secondary Board or equivalent, constituted or recognized by the Union or by the State Government or from any equivalent institution from a foreign country recognized by the government of that country for the purpose of issue of qualifying certificate on successful completion of the course, may apply for and be admitted into the course.

(b) **Minimum percentage of marks** in qualifying examination shall not be below 45% (44.5% and above shall be treated as 45%) of total marks in case of General category applicants, 42% (41.5% and above shall be treated as 42%) for OBC category and 40% (39.5% and above shall be treated as 40%) of total marks in case of SC and ST applicants.

Note : 1. Students having marks / grade points (CGPA) in the marks card of each semester should submit a certificate of conversion of percentage from the concerned school/board/university along with the application.

2. If the Student does not submit certificate of conversion of percentage then the candidates are may be rejected.

(c) **Maximum age *** for seeking admission is limited to 20 yrs (twenty years) in case of General category applicants and 22 yrs (twenty two years) in case of applicants from SC, ST and Other Backward Communities as on 30.05.2025.

Explanation:

Provided that the applicants who have obtained +2 Higher Secondary Pass Certificate or First Degree Certificate after prosecuting studies in distance or correspondence method shall also be considered as eligible for admission to 5 year LL.B. programme.

Provided further that the applicants who have obtained 10+2 or graduation or post-graduation through open University system directly without having any basic qualification for prosecuting such studies are not eligible for admission to the Law programme.

****A Writ Petition (civil) No. 1023/2016 is pending before the Supreme Court of India regarding the maximum age limit prescribed for admission. The admission of the students who have crossed the age limit is subject to the outcome of the said writ petition. In this regard, college has to obtain an undertaking from the students who have crossed the age limit in the proforma enclosed.***

a) The Principal shall verify the promotional eligibility of the students for admission to next class/year of the course. In this regard, principal has to enclose the certificate stating that, the student has fulfilled the promotional eligibility criteria for the course.

- b) The admissions for subsequent years shall be made as per Admission Time Table of 2023-20, by enclosing all **previous semester marks cards. Incomplete applications shall be liable to be rejected.**
- c) The Statement of admission in proforma-1, 2 3 & 4 shall be submitted to aracademic.kslu@gmail.com on or before **08.07.2025**.
- d) The Proforma no: 1 to 4, of consolidated admission statements in A4 size papers shall be bound into a single booklet along with the covering letter (with details of fee paid) & shall be addressed to the Registrar, Karnataka State Law University, Hubballi, and be submitted at the time of original document verification.

2) **ADMISSION PROCEDURE**

- a) Admission to the programme shall be made strictly on the basis of merit cum reservation basis. While making admission to the course reservation policy of the Government of Karnataka governing admissions to higher educational institutions issued from time to time shall be observed strictly.
- b) The admission of the students has to be on the basis of Merit cum Reservation. The Reservation policy as notified by the Government of Karnataka has to be adhered to.

3) **FEES**

- a) All Principals are strictly instructed to collect the fees as prescribed by the University and Government of Karnataka.
- a) The college shall apply to District Social Welfare/BCM Department concerned for the reimbursement of SC/ST/OBC students fees.
- b) All the Principals are strictly instructed that if previous years admission fees have not been remitted to University fully then, present year admissions will not be approved at the time of Admission verification for the year 2024-25.

4) **INTAKE**

No College shall admit the students in excess of the sanctioned intake provided by the University and Bar Council of India.

5) **THE COLLEGE AUTHORITY SHOULD STRICTLY VERIFY -**

- a) The eligibility of the students should be as per BCI rules & KSLU admission regulations before admitting the students to the programmes.
- b) The students shall be asked to produce the Migration and Transfer Certificates within fifteen days from the date of admission.
- c) In case of applicants from Foreign Universities/Boards, the applicant should have obtained the valid passport, visa, Residential permit, and "Students Study Permission/NOC" from Foreign Embassies of both the nations. They should also obtain a certificate that the degree is obtained from a recognized Board/University from the embassy concerned in India.
- d) In case of applicants from Foreign Universities/Boards, the applicant shall be asked to produce the "Equivalence Certificate" issued by the Association of Indian Universities (AIU), New Delhi if necessary.
- e) At the time of documents verification by the University for admission approval, the college should submit the originals of above documents & 'Eligibility Certificate' (wherever applicable).

- f) The Principal of the college shall verify the original documents and attest the copies thereof.
- g) The Principal of colleges should certify that the admissions (for all classes) of course/s are made as per the admission rules of Karnataka State Law University, Hubballi and Government of Karnataka.
- h) In case a student is an employee either in State/Central/Private organization, he/she shall submit No Objection Certificate from employer concerned stating that the working hours do not conflict with college timings and the Principal should certify that the candidate is capable of attending 70% of classes.
- 8) **THE COLLEGE AUTHORITIES SHALL ENSURE SUBMISSION OF THE NECESSARY DOCUMENTS BY THE APPLICANT TO THE COLLEGE, AS BELOW.**
- a) The Eligibility Certificate issued by the University, in case of Non-Karnataka and Foreign students at the time of admission.
- b) 10, +2 Marks cards for 5 year B.A. LL.B., B.B.A,LL.B. and B.Com.,LL.B. admission at the time of admission.
- c) In case of SC/ST/Cat-1/OBC student, **Caste & Income certificate** shall be submitted by student to the college at the time of admission if they claim Fee Exemption.

- **Consolidated admission statement in Proforma No: 02 along with admission applications with necessary attested documents to be submitted at the time of original documents verification.**
- **The Proforma No 1 to 4, of admission statements along with the covering letter (with details of fee paid) addressed to the Registrar, Karnataka State Law University, Hubballi, and be submitted at the time of original document verification .**
- **Incomplete information in the Proforma will be rejected and admissions of the college will not be approved or may be withheld for want of information.**
- The serial numbers of candidates in subsequent admission statements viz, Proforma III, shall be in continuation with the 1st list of admission statement.
- Admission statement in proforma - III should be prepared as per the date of admission serially, not in alphabetical order.
- Fees collected shall be remitted through online (**SBI Collect**). The admission statements and the fees paid details shall be submitted to the Registrar, KSLU along with the **Proforma No: 04** containing details of fees.


1) In complicated/doubtful cases, the principal of the college may seek clarification from the Academic Section.



******The colleges are required to remit the admission fees of the students to the University on or before 05.11.2025 mandatorily.**

ELIGIBILITY CERTIFICATE

- A. An applicant who has graduated in law from a University established by an Act of Parliament or by a State Legislature or an equivalent national institution recognized as a Deemed to be University or Foreign University recognized as equivalent to the status of an Indian University by an authority competent to declare equivalence, may apply for LL.M. degree programme.
- B. Minimum percentage of marks in qualifying examination shall not be below 45% of total marks in case of General Category applicants and 40% of total marks in case of SC and ST applicant.
- C. The applicant who has passed the prescribed qualifying examination from recognized University / Boards of examination that are situated outside Karnataka or in a Foreign Country shall compulsorily obtain the ELIGIBILITY CERTIFICATE before taking the admission.
- D. Such candidates may apply for the Eligibility Certificate to the Karnataka State Law University through **Seva Sindhu** by paying necessary fees along with attested documents of 10th, 12th& U.G. marks cards, as applicable along with transcripts and **Grade conversion certificate** (if applicable) issued by the University or Board or Department concerned.
- E. The qualifying degree/certificates should be in Kannada or English only.
- F. All those candidates who have obtained qualifying degree certificate from outside Karnataka state should produce the countersigned original certificates from the issuing authorities/Universities otherwise eligibility will not be considered.
- G. Fees for Eligibility certificate for LL.M. Programme is as notified in the LL.M. fee notification of the University.

ADMISSION GUIDELINES:

Instructions to the Post-Graduation Centers regarding the admissions to Two Year LL.M. Programme for the academic year 2025-26.

The applications for admission and the admission statement should be as per Proforma prescribed by the University. The admission statements in Proforma-1 and 2 shall be forwarded to the University on 30.10.2025.

The eligibility for admission is as given below:

Two year LL.M. Programme

(a) An applicant who has graduated in Law from a University established by an Act of Parliament or by a State Legislature or an equivalent national institution recognized as a Deemed to be University or Foreign University recognized as equivalent to the status of an Indian University by an authority competent to declare equivalence, may apply for Two Year LL.M. Programme in Law leading to the conferment of Two Year LL.M. degree on successful completion of the regular

programme conducted as per the Karnataka State Law University Ordinance.

(b) Minimum percentage of marks in qualifying examination shall not be below 45% of total marks in case of general category applicants and 40% of total marks in case of SC and ST applicants.

ADMISSION PROCEDURE:

a) Admission to the course shall be made strictly on the basis of merit cum reservation taking into account total marks obtained in the qualifying examination. While making admission to the programme reservation policy of the Government of Karnataka governing admissions to higher educational institutions issued from time to time shall be observed.

b) Reservation for Hyderabad-Karnataka students under Art 371 (j) as per rules shall be adhered to i.e. 8% of the seats shall be reserved for them.

FEES

As notified by the University from time to time.

INTAKE

No College shall admit the students in excess of the sanctioned intake.

THE COLLEGE AUTHORITY SHOULD VERIFY:

- ❖ The eligibility of the students as per BCI rules & KSLU admission regulations before admitting the students to the programme.
- ❖ The students shall be asked to produce the Migration and Transfer Certificates within one month from date of admission.
- ❖ In case of applicants from Foreign Universities/Boards, the applicant should have obtained the valid passport, visa, Residential permit, and “Students Study Permission/NOC” from Foreign Embassies of both the nations. They should also obtain a certificate that the degree is obtained from a recognized Board/University from the concerned embassy in India.
- ❖ In case of applicants from Foreign Universities/Boards, the applicant shall be asked to produce the “Equivalence Certificate” issued by the Association of Indian Universities (AIU), New-Delhi.
- ❖ At the time of documents verification by University for admission approval, the college should submit the originals of above documents & “Eligibility Certificate” (Wherever applicable).
- ❖ The Principal of the college shall verify the original documents and attest the copies thereof.
- ❖ The Principal of colleges should certify that the admissions (for all classes) of course/s are made as per the admission rules of Karnataka State Law University, Hubballi and Government of Karnataka.

- ❖ In case a student is an employee either in State/Central/Private organization, he/she shall submit No Objection Certificate from employer concerned stating that the working hours do not conflict with college timings and the Principal should certify that the candidate is capable of attending 70% of classes.
- ❖ The Principal of the colleges should certify that the admissions are made as per the admission rules of Karnataka State Law University, Hubballi and Government of Karnataka.
- ❖ In case a student is an employee either in State/Central Private organization, he shall submit a study permission letter from concerned employer stating that the working hours do not conflict with college timings and the Principal should certify that the candidate is capable of attending 75% of classes.

THE COLLEGE AUTHORITIES SHALL ENSURE SUBMISSION OF THE NECESSARY DOCUMENTS BY THE APPLICANT TO THE COLLEGE, AS BELOW:

a) The Eligibility Certificate issued by the University, in case of Non-Karnataka and Foreign students (for Two LL.M. Programme), at the time of admission,

b) 10, +2, U.G. and LL.B. Degree Marks cards of all years/Semesters & Passing certificate at the time of admission.

c) The transfer & Migration Certificates shall be submitted by student to the college at the time of admission or within one month from the date of admission to the college.

d) In case of SC/ST.Cat-1/OBC student, Caste & Income certificate shall be submitted by student to the college at the time of admission.

- Consolidated admission statement in Proforma No. 02 along with admission applications with necessary attested documents to be submitted at the time of original documents verification.
- The Proforma No: 01 to 04, of admission statements along with the covering letter (with details of fee paid) addressed to the Registrar, Karnataka State Law University, Hubballi, and be submitted at the time of original document verification.
- Incomplete information in the Proforma will be rejected and admissions of the college will not be approved or may be withheld for want of information.
- The serial numbers of candidates in subsequent admission statements viz, Proforma III, shall be in continuation with the 1st list of admission statement.
- Admission statement in Proforma-III should be prepared as per the date of admission serially, not in alphabetical order.

- Fees collected shall be remitted through online (State Bank Collect). The admission statement and the fees paid details shall be submitted to the Registrar, KSLU along with the Proforma No: 01 containing details of fees.

Note:

- 1) In case of complicated doubtful matters the Principal of the college may seek clarification from the academic section.
- 2) The college/s shall admit the student/s only after verification of the necessary documents & eligibility certificate for fulfillment of eligibility criteria. **In case any college admits in-eligible candidate/s to any course, the Principal will be responsible for further consequences in the matter of non-approval of such admission/s.**
